### Middlesex County Invitational

MARK RUDNER, KEN HAGREAVES AND GREG WORNELL TAKE THE TROPHY SPOTS

MAY 24, 2008 – BILLERICA, MA – This contest came about because of the willingness of the Middlesex County RC Flyers to share their flying site at Vietnam Veterans Park in Billerica, Massachusetts. Due to their generosity it was time to get the New England F2D season off to a good start. Eight pilots were on hand and ready for action.

Rounds I and II were somewhat uneventful with the majority of the field looking quite competitive. Three pilots; Mark Rudner, Jeff Vader and Greg Wornell were undefeated while three others had been eliminated. Still in contention, as well, were Roy Glenn and Ken Hargreaves both sitting with one win and one loss apiece. In Round three things started to get interesting. Mark handed Greg his first loss in a full four minutes of twisting and turning both pilots looking very sharp. Round three also saw Roy Glenn, who had made the long trip from Southampton, NJ, hand Jeff Vader his first loss. Next Ken Hargreaves matched up against Mark Rudner. It was Ken's third match, Marks fourth. This one was a hard fought, action filled match with Ken emerging victorious. Later in round four Ken eliminated Jeff while Greg did likewise to Roy. After three rounds of action seven pilots were still in the hunt most sitting at two wins and one loss. In round four both Jeff Vader and Mark Rudner moved to 3 wins and one loss while everyone else accumulated their second loss. Jeff earned his third win getting past Neil Simpson two cuts to one in a match where both pilots flew well. Next Mark got his third win when he faced off against Roy Glenn. Mark got all of Roy's streamer very early and then exhibited great defensive skills as Roy had him running. Roy chased hard while also staying under control. Roy's patience seemed to be rewarded with a nice cut with about nine seconds left, however a penalty cost him what looked like a tie. Jeff and Roy then faced off for first place with Mark earning the match and contest win. In a four way fly-off for third Brian Stas earned the spot getting past Neil, Roy and his son Matt in the process.

Weather conditions were cloudy, some drizzle, but mostly dry and seasonably cool, a great day for combat.

Round one saw Neil Simpson and Jeff Vader both get off to fast starts posting 725 point wins. They met each other in round two with Jeff prevailing two cuts to one in a very exciting match that went buzzer to buzzer. In the next match Brian Stas posted his second good win getting past Glenn Simpson two cuts to one in a match where both pilots flew very well. Round three saw Brian and Jeff fly to a one cut apiece draw followed by a match where Neil and Glenn flew to a two cut apiece draw.

Going into round four it was Jeff (1960pts), Brian (1855pts), Neil (1740pts) and Glenn (1535pts). In the first match of round four Rick Clark earned a three cut win to put pressure on the leaders. In the semi-final Brian and Neil waged war. Great action for the whole match with Brian leading by a cut, when with just a few seconds to go a major league mid-air occurred. In the finals Jeff got pat Glenn three cuts to one to earn the contest win. When the scores were tabulated Jeff was first, Brian second and Rick third. Chris Sarnowski, flying in his first contest, took home the sportsman "gold".



The match starts and the goal is to cut your opponent's streamers.

My grandfather taught my dad and my dad taught me how to build and fly model airplanes. Every time I fly I think of my heritage. There are times when you're mad at your decision. At the end however, you always will like it. Building and flying planes is something I truly love.
