### Len Minick Memorial Combat Challenge

NEIL SIMPSON, CHRIS SARNOWSKI & JOE FUSTOLO ARE TOP THREE

#### SPORTSMAN TO JAKE VADER

JUNE 27, 2010 – EAST HAMPTON, CT – This was the seventh annual Len Minick Memorial Combat Challenge held in tribute to and in memory of our good friend and fellow competitor. The weather was warm and very humid. Nine contestants made the trip to the Salmon River State Forest and enjoyed a day of very competitive combat.

Round one saw Dana Lord and Chris Sarrnowski get off to good starts posting 725 point and 620 point wins respectively, while the rest of the field struggled. Dana and Chris, faced off in round two and flew to a very low scoring draw. This seemed to open things up for the rest of the field, but no, the next three matches ended in mid-airs early so Dana and Chris held their leads at the halfway point. Round three started with Jeff Vader getting past Dana with an airtime win. Next Joe Fustolo and Chris faced off. The match was tied a cut apiece when Chris got a second cut late to grab the win and the outright contest lead. In the final round three match Neil Simpson, after a very bad start, got a two cut win over Paul Kubek to stay within range. Going into round four it was Chris with 1555 points followed by Neil (1325pts), Dana (1235pts), Jeff (1230pts), Joe (1110pts), Brian Stas (1020pts) and Glenn Simpson (1010pts). Early in round four Brian got a 620 point win over Jake Vader to put some pressure on the field. Next Jeff and Glenn midaired hurting both their chances. In the semi-final Joe got a 620 point win over Dana to put himself on the trophy stand. In the final Chris and Neil had a good match going. Neil managed a cut about midway through that stood up for both the match and contest win. When the dust settled the final order of finish was Neil, Chris and Joe. The sportsman division winner was Jake Vader from Franklin, New Hampshire.

Thank You, to everyone who participated and to those who shared in the judging. A special thank you to Ernie Carosella who came and pitted for Dana Lord, who was

flying with us for the first time in a long time. It was great to have both Ernie and Dana at the contest.





### **F2D News - July 2010**

SPECIAL CONTEST ANNOUNCEMENT: This month I am excited to report that the New England Cup of F2D, which has long been a dream, is now set to become reality. The contest is scheduled for September 25-26, 2010 on the beautiful grounds of Silver Lake High School in Kingston, MA. As some of you may recall, I have written about this field previously in the F2D News. We have held smaller events here before, and everyone agrees that the nicely groomed athletic pitch is about the best setting anyone could hope to fly on. It's a first-rate site, and our plan is to host a first-rate competition to match it.

I've been living in the Boston area for nearly 7 years now. A week after my arrival, I drove out to Worcester, MA to take part in the New England Championships of Formula GX Combat. Amidst all the nerves of moving to a far-away place and starting graduate school, it was really comforting to find a thriving community of combat pilots in my new home. Before coming I knew that the community existed based on contest reports and names I'd seen in the MACA News. However, there seemed to be a sort of separation between East and West, with little mixing between our communities. After meeting the New England combat crew, and finding out that there is a whole community of great guys and dedicated fliers out here, I got the feeling that it would be really beneficial for everyone to see more cross-pollination. In particular, I had a dream to bring F2D combat to New England, and to host a big competition on the scale of the Houston World Cup here. The idea was both to give our guys the chance to fly with some of the top pilots from other parts of the country (hopefully other countries too!), and to introduce the rest of the country to the enthusiastic group of fliers that we have out here.

It is my sincere hope that many of you from outside the New England area will come out for this event. Weather-wise this should be one of the best times of the year, and I think it will give people a chance to come fly in a new (and of course historic) part of the country (Plymouth rock, where the pilgrims landed with the Mayflower, is only a few miles from the contest site). Kingston is conveniently accessible from Boston Logan International Airport, and is within a day's drive from Detroit and all points in between (I made the drive personally for the Team Trials last year). We will post more information about lodging options soon. Please email me if you have any questions. Looking forward to seeing you here!

Position in the season point standings is determined by the percentage column. The formula to determine percentage is total points accumulated divided by total possible points. Points are awarded in decending order for the first ten places in each contest (1st Place = 10pts, 2nd Place = 9pts etc.) Total possible points is the number of contests participated in multiplied by ten. Participation in no less then 50% of the New England regular season GX meets is the elegibility requirement for a season championship award.
